1. HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE CTTPA AS AN ASSOCIATION INCLUDING ALL ITS CORPORATE ELECTED AND APPOINTED OFFICIALS, ALL MEMBERS OF COMMITTEES, REFEREES AND INSPECTORS, ITS INDIVIDUAL MEMBERS, AGENCIES FO GOVERNMENT WHICH CONTROL ESSENTIAL EVENT SITES, AND FINANCIERS WHICH RENDER ESSENTIAL GRATIS, INCLUDING ALL OFFICERS, AGENTS AND EMPLOYEES FO THE FOREGOING AND VOLUNTEER WORKERS ASSISTING IN SANCTIONED CTTPA EVENT ACTIVITES, ALL HEREINAFTER REFERRED TO AS "releases" from or for any and all liability to me, my personal representatives, heirs, next of kin, successors and assigns, for all loss or damage for bodily injury, or death or damage to property of the undersigned which in any way grows out of or results from any CTTPA event activity or part thereof, during the actual sanction period and whether any such claim may be based upon alleged breach of any statutory duty or obligations; and
